Conditions of Loans

Applicants must have completed at least four course credits and have maintained a minimum QPA of 2.75. The maximum amount a student can borrow from the fund is \$2,000. Recipients must be full-time students when the approved amount of the loan is paid to Framingham State University. These payments are made in full after Add/Drop Day in the fall or spring following approval.

Educational loans are made without interest. Repayment of the entire amount of the principal will be made on either completion or termination of undergraduate studies at Framingham State University, on a payment schedule of \$50.00 a month (a minimum rate of \$600.00 per year).

Historical Note

Ellen Hyde graduated from the State Normal School at Framingham in 1862, taught in the school until 1875 and then became its principal until 1898. She was an inspiring teacher and a builder of character in her pupils. From her intimate knowledge of the struggle many students had to pay their way, she felt the need for a fund that could be used to help them.

This interest-free loan fund is administered by a Board of Trustees, elected by the alumni members of the Independent Association of Framingham State Alumni, and used to assist undergraduate students of Framingham State University.
